



**Calumet County (WI):** No current ordinances found. (2022)

*County Seat: Chilton WI*

#### *Cities*

**Appleton (City):** Crocodilians, any poisonous reptiles, any other snake or reptile exceeding 6 feet prohibited.

**Brillion (City):** All poisonous animals and reptiles including rear fanged snakes, crocodilians, constrictor snakes over 3 feet, poisonous insects prohibited.

**Chilton (City):** Any venomous reptile or snake, constrictor snake or any nonvenomous snake more than five feet in length at maturity, lizard more than five feet in length at maturity, poisonous insect or arachnid, crocodilians prohibited.

**Kaukauna (City):** All reptiles prohibited.

**Kiel (City):** Any poisonous or venomous, biting or injecting species of reptiles, amphibians, arachnids, or insects, Snakes not indigenous to Wisconsin or any snake exceeding three feet prohibited.

**Menasha (City):** Poisonous animals/reptiles (including rear fanged snakes), crocodilia >30", constrictor snakes 6 feet or more, poisonous insects prohibited.

**New Holstein (City):** Any poisonous or venomous snakes, biting or injecting species of reptiles, amphibians, arachnids, or insects prohibited.

#### *Villages*

**Harrison (Village, partial):** Any poisonous or venomous reptiles or animals including rear fanged snakes, crocodilians, constrictor snakes, poisonous insects and arachnids prohibited.

**Hilbert (Village):** All "poisonous" animals and reptiles including rear fanged snakes, poisonous insects, crocodilians >30", and constrictor snakes 6 feet or over prohibited.

**Potter (Village):** No current ordinances found. (2022)

**Sherwood (Village):** Exotic animals (any animal not normally domesticated or wild by nature) prohibited. Small, indoor caged reptiles, aquatic, or amphibians allowed.

**Stockbridge (Village):** No current ordinances found. (2022)
