



**Columbia County (WI): No current ordinances pertaining to reptiles. (2022)**

*County Seat: Portage WI*

*Cities*

**Columbus (City):** “Poisonous” snakes, snakes exceeding 3 feet, “dangerous” insects prohibited. Exemption for snakes exceeding 3 feet in public or parochial schools.

**Lodi (City):** Poisonous animals/reptiles (including rear fanged snakes, crocodylia >30”, constrictor snakes 6 feet or more, poisonous insects prohibited.

**Portage (City):** Poisonous animals/reptiles (including rear fanged snakes, crocodylia >30”, constrictor snakes 6 feet or more, poisonous insects prohibited.

**Wisconsin Dells (City):** “Wild” or “viscous” animals prohibited including snakes and other reptiles. Viable turtle eggs and live turtles under 4” prohibited from sale.

*Villages*

**Arlington (Village):** All “poisonous” animals and reptiles including rear fanged snakes, crocodilians >30”, constrictor snakes, “poisonous” insects prohibited.

**Cambria (Village):** All poisonous animals and reptiles including rear fanged snakes, crocodilians 30” or greater, constrictor snakes 6 feet or more, poisonous insects prohibited.

**Doylestown (Village):** No official website/ordinance information available online. Inquire discreetly with your local clerk’s office and municipal hall. (2022)

**Fall River (Village):** All "poisonous" animals and reptiles including rear fanged snakes, constrictor snakes, crocodilians >30", "poisonous" insects prohibited.

**Friesland** (Village): All "poisonous" animals and reptiles including rear fanged snakes, constrictor snakes, crocodilians >30", "poisonous" insects prohibited.

**Pardeeville** (Village): Poisonous animals/reptiles (including rear fanged snakes, crocodylia >30", constrictor snakes 6 feet or more, poisonous insects prohibited.

**Poynette** (Village): All "poisonous" animals and reptiles including rear fanged snakes, constrictor snakes 6 feet or greater, crocodilians >30", "poisonous" insects prohibited.

**Randolph** (Village): All "poisonous" animals and reptiles including rear fanged snakes, constrictor snakes, crocodilians >30", "poisonous" insects prohibited.

**Rio** (Village): Ordinances not listed online; Inquire discreetly with your local clerk's office and municipal hall. (2022)

**Wyocena** (Village): All "poisonous" animals and reptiles including rear fanged snakes, constrictor snakes, crocodilians >30", "poisonous" insects prohibited.
