Stephenson (Town): Crocodylians 30" or greater, Varanidae (only crocodile and water monitors), any other reptile or other animal not normally domesticated in Wisconsin or inherently wild by nature prohibited without permit, caging, and other requirements. Limitation of 2 animals.
