



Saint Croix County (WI): No current ordinances found. (2022)

County Seat: Hudson WI

Cities

Glenwood City (City): All poisonous animals and reptiles including rear fanged snakes, crocodilians 30 inches or greater, constrictor snakes 6 feet or more, poisonous insects prohibited.

Hudson (City): Any “poisonous” and/or “large reptile over 18 inches prohibited except under conditions set by City Council.

New Richmond (City): Crocodilians >30”, constrictor snakes > 6 feet, “poisonous” animals, insects, and reptiles including rear fanged snakes prohibited.

River Falls (City): Wild animals subject to secure enclosure, licensing provisions. Crocodilians greater than 4 feet, snakes greater than 6 feet, Venomous snakes and other reptiles.

Villages

Baldwin (Village): Poisonous animals/reptiles (including rear fanged snakes), crocodylia >30”, constrictor snakes, poisonous insects prohibited.

Deer Park (Village): No pertinent ordinances found (2022)

Hammond (Village): Venomous reptiles, crocodilians, large snakes exceeding 3 feet prohibited without permitting requirements.

North Hudson (Village): No current ordinances found. (2022)

Roberts (Village): No current ordinances found. (2022)

Somerset (Village): Poisonous animals/reptiles (including rear fanged snakes), crocodylia >30”, constrictor snakes 6 feet or more, poisonous insects prohibited.

Spring Valley (Village): Poisonous animals/reptiles (including rear fanged snakes), crocodylia >30”, constrictor snakes 6 feet or more, poisonous insects prohibited.

Star Prairie (Village): All poisonous animals and reptiles including rear fanged snakes, Crocodilians 30 inches or greater, constrictor snakes, poisonous insects prohibited.

Wilson (Village): No official website/ordinances found online. Inquire discreetly with your local clerk’s office and municipal hall.

Woodville (Village): Poisonous animals/reptiles (including rear fanged snakes), crocodylia >30", constrictor snakes 6 feet or more, poisonous insects prohibited.

Towns

Baldwin (Town): No pertinent ordinances found. (2022)

Cady (Town): Exotic animals prohibited without permitting requirements. Includes venomous reptilia, Varanidae (only water and crocodile monitors), crocodilians, missing pages for constrictors.

Cylon (Town): No pertinent ordinances found (2022)

Eau Galle (Town): No current ordinances found. (2022)

Emerald (Town): No pertinent ordinances found (2022)

Erin Prairie (Town): No current ordinances found. (2022)

Forest (Town): No current ordinances found. (2022)

Glenwood (Town): No pertinent ordinances found. (2022)

Hammond (Town): Crocodilians, venomous reptilia, reptilian over 3 feet prohibited without permitting requirements.

Hudson (Town): No current ordinances found. (2022)

Kinnickinnic (Town): No current ordinances found. (2022)

Pleasant Valley (Town): No pertinent ordinances found (2022)

Richmond (Town): No current ordinances found. (2022)

Rush River (Town): No pertinent ordinances found (2022)

Somerset (Town): Crocodilians, Venomous reptiles including boomslangs and twig snakes and other life threatening rear fanged snakes, Boidae (pythons and boas), any other life threatening insects and arachnids prohibited.

Springfield (Town): No pertinent ordinances found (2022)

St. Joseph (Town): Any snake or other reptile prohibited.

Stanton (Town): No pertinent ordinances found. (2022)

Star Prairie (Town): Crocodilians 30 inches or greater, Varanidae (water monitors and crocodile monitors), any other type of dangerous or carnivorous wild animal, fowl, or reptile prohibited.

Troy (Town): No current ordinances found. (2022)

Warren (Town): Permit required. Crocodilians 30" or greater, Varanidae (only water and crocodile monitors), any other dangerous, or wild animal or reptile otherwise prohibited.

Unincorporated and Census Designated Communities:

Unincorporated and Census-Designated Communities are smaller communities that are governed either by the townships, or counties they are located in, and often exist as nomenclature in vital records, and which may be more frequently changing.
