Nekoosa (City): Any venomous animal, including any venomous snake, lizard, or other reptiles, any animal normally found in a wild state prohibited.

Pittsville (City): All poisonous animals and reptiles including rear fanged snakes, crocodilians 30” or greater, constrictor snakes 6 feet or more, poisonous insects prohibited.

Wisconsin Rapids (City): All poisonous animals including rear fanged snakes, constrictor snakes 6 feet or more, crocodilians, bees/wasps/hornets, poisonous insects prohibited.
